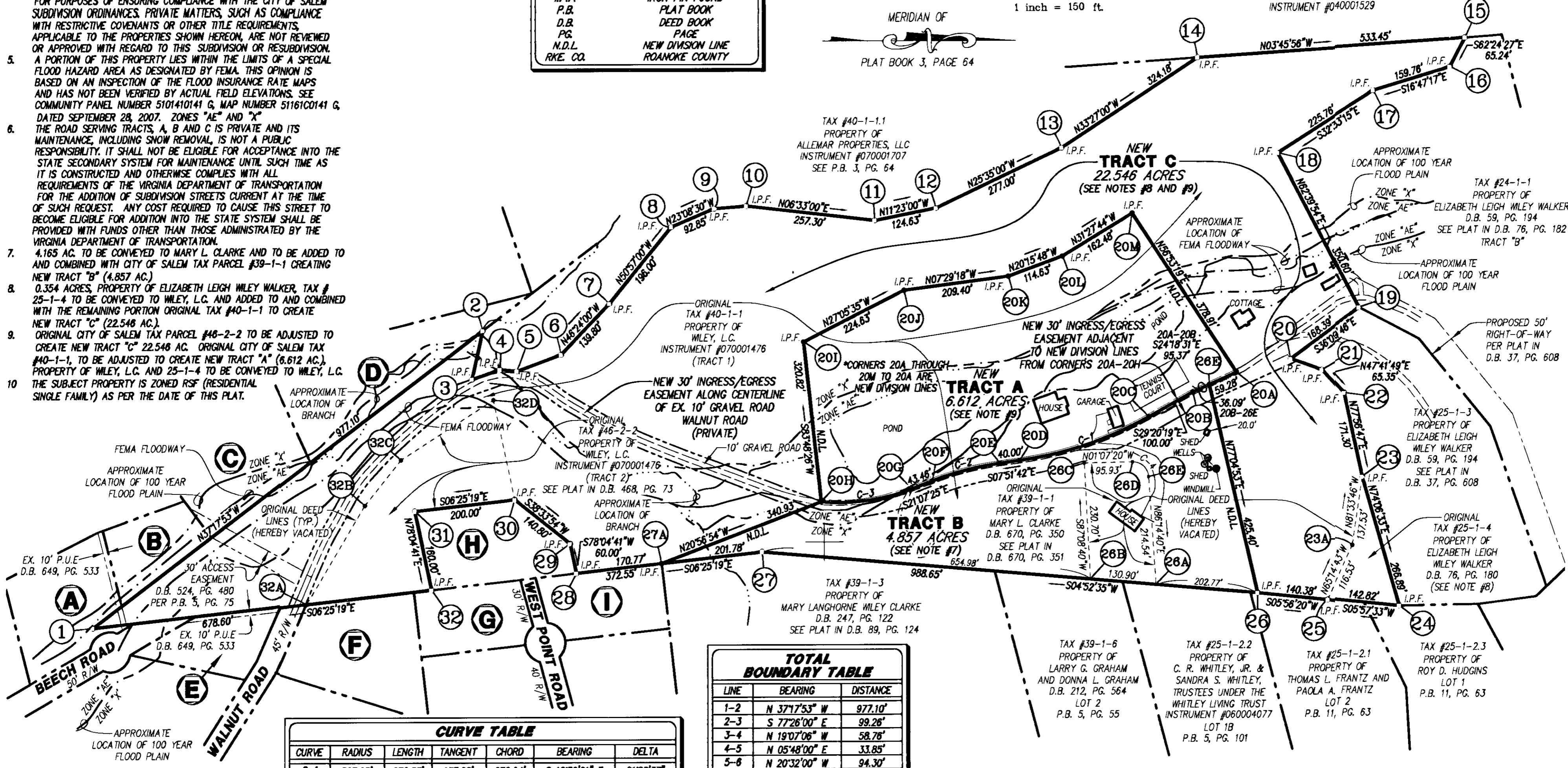
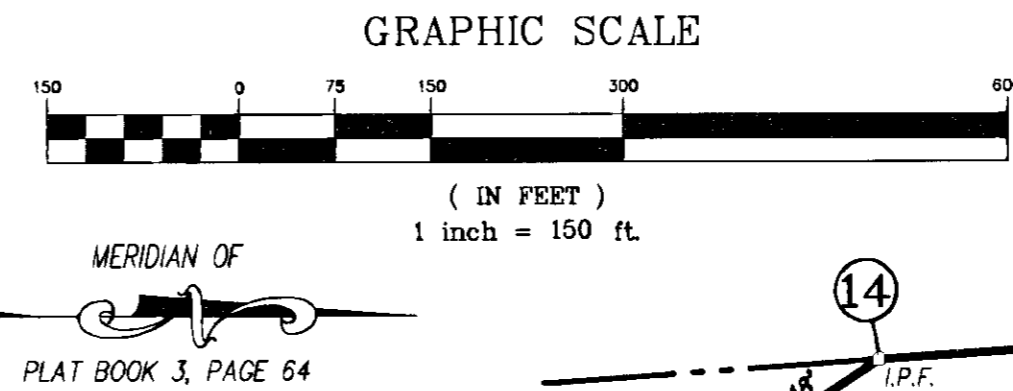


PLAT SHOWING VACATION AND COMBINATION FOR CITY OF SALEM TAX #39-1-1 SHOWING

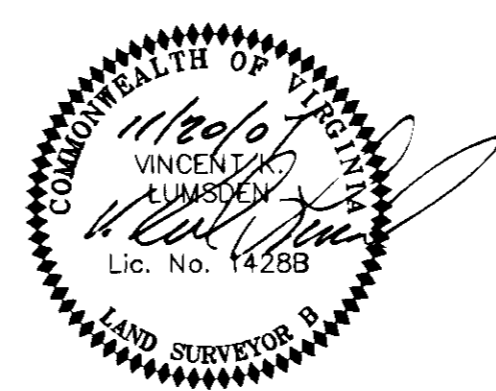

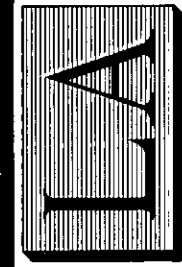
