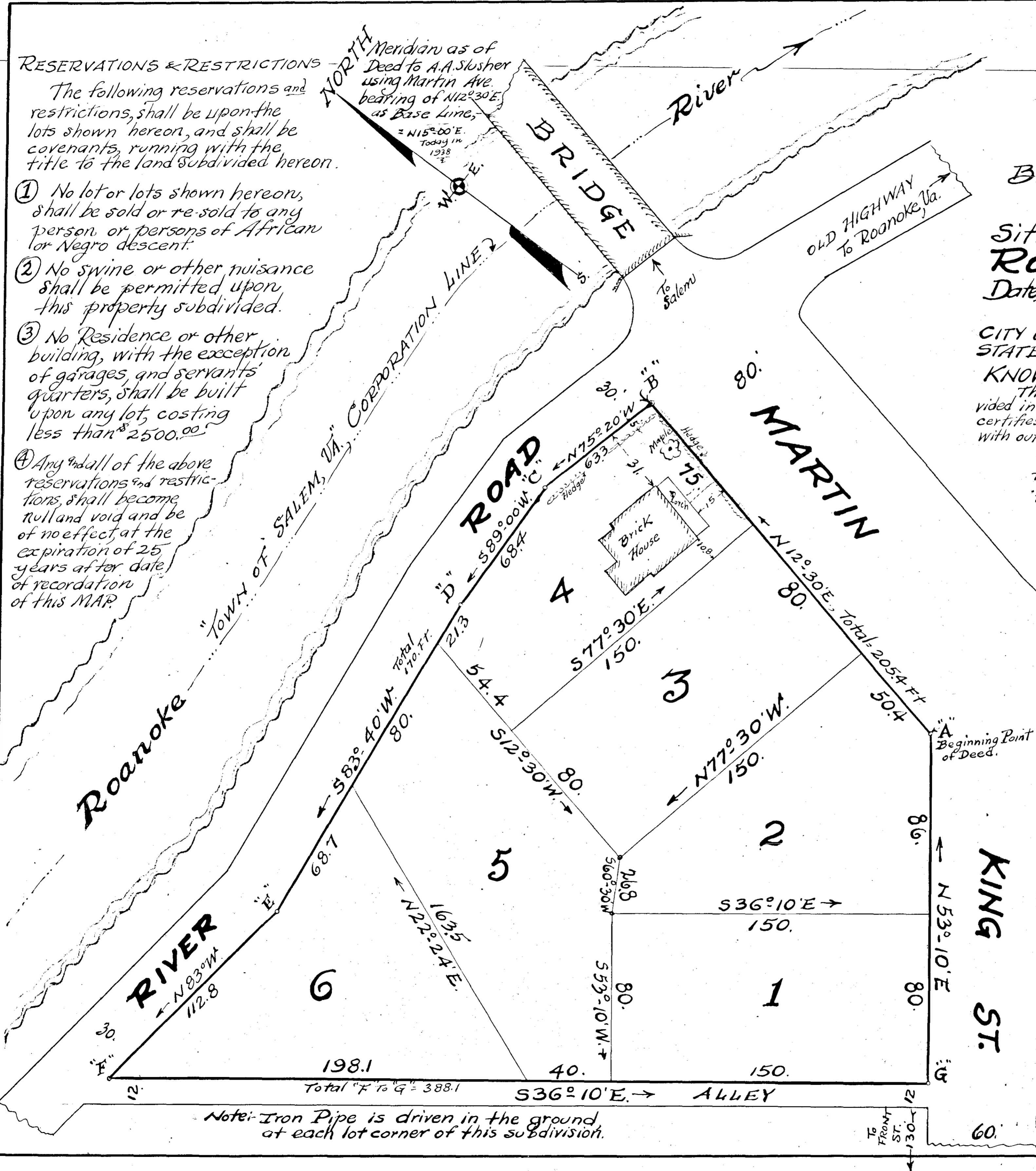

RESERVATIONS & RESTRICTIONS  
The following reservations and restrictions, shall be upon the lots shown hereon, and shall be covenants, running with the title to the land subdivided hereon.

- 1) No lot or lots shown hereon, shall be sold or re-sold to any person or persons of African or Negro descent.
- 2) No swine or other nuisance shall be permitted upon this property subdivided.
- 3) No Residence or other building, with the exception of garages, and servants' quarters, shall be built upon any lot, costing less than \$2500.00
- 4) Any and all of the above reservations and restrictions, shall become null and void and be of no effect, at the expiration of 25 years after date of recordation of this MAP.



Note: Iron Pipe is driven in the ground at each lot corner of this subdivision.
