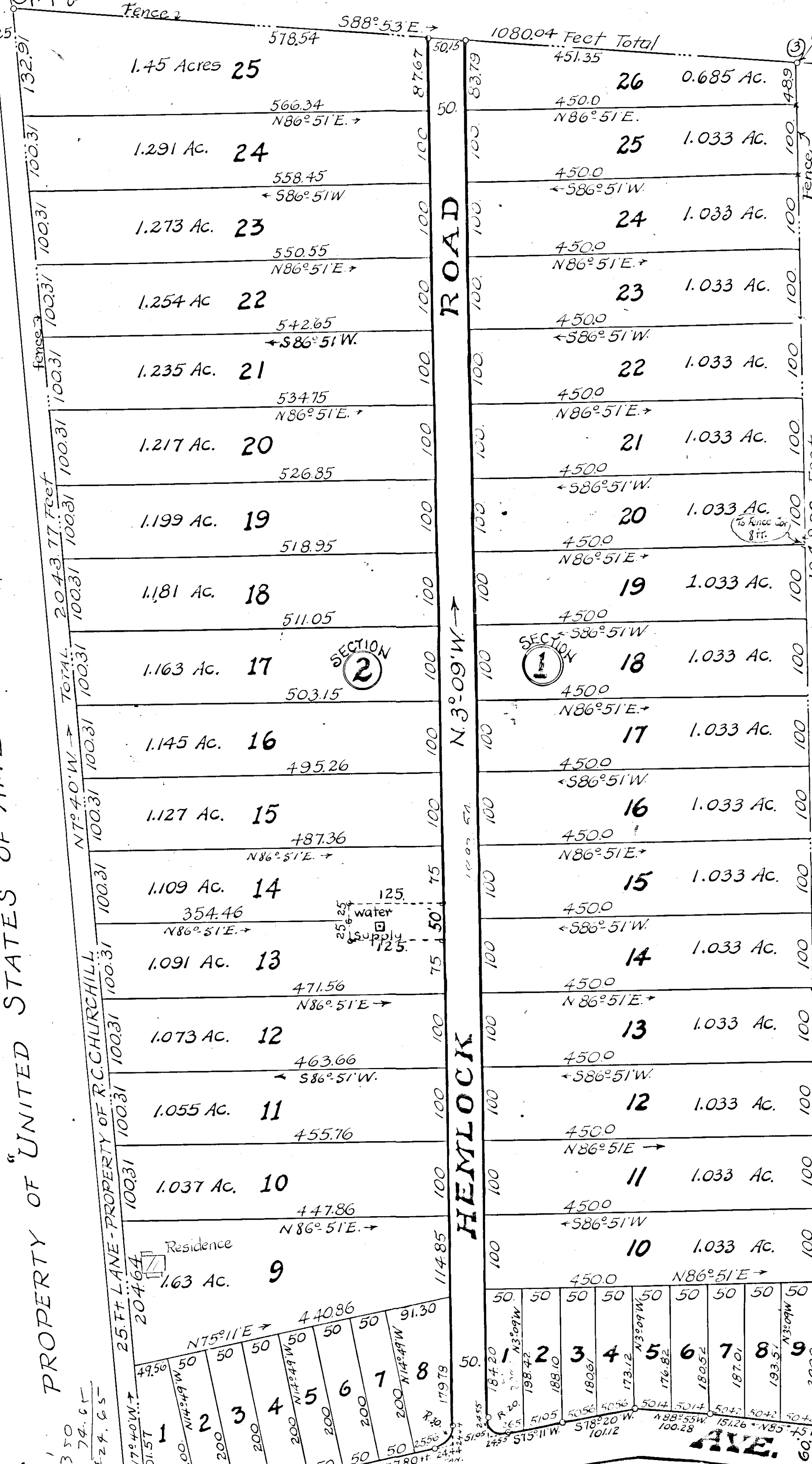

KNOW ALL MEN BY THESE PRESENTS: To Wit:-
That Thomas S. Wright is the owner of the land shown hereon, with outside boundary line corners (1) (2) (3) and (4), which outside boundary line is described as follows:
Beginning at (1) at the point of intersection of the easterly side of R.C. Churchill's 25 ft Lane, with the Northerly side of Boulevard Avenue (60 ft wide); thence along the easterly side of said Lane, N7°40'W, 2043.77 ft to a fence post at corner (2); thence with a new division line through the property of T.S. Wright, S88°53'E, 1080.04 feet to a fence post corner at (3); thence with the westerly line of the property of E.A. Roades (formerly "HENRY") and with the existing fence line, S3°09'E, 1848.90 feet to corner (4), on the Northerly side of Boulevard Avenue (60 ft wide); thence along the said northerly side of said Boulevard, the following four courses and distances, N88°45'W, 151.26 ft; N88°55'W, 100.28 ft; S78°20'W, 101.12 ft; S75°11'W, 577.80 ft. to the place of beginning, and being the southerly portion of the Lands of Thomas S. Wright, of record in the Clerk's Office of the Circuit Court of Roanoke County, Virginia, in Book 118, Page 213.
