 That Hattie Belle Mounts and Amos D. Mounts were the owners of the original 17.34± Acre tract, conveyed to said owners by the Trustees of Roanoke College, by Deed dated Feb. 7, 1939, of record in the Clerk's Office of the Circuit Court of Roanoke County, Va., in Deed Book 261 - Page 140.
 The said owners further certify that they have subdivided a portion of their land, as shown hereon, entirely with their own free will and consent, in compliance with the Virginia 1950 Code, Sections 15-779 through 15-794.3, as amended to date, and further pursuant to and in compliance with Title 15, Chapter 11 of "LAND SUBDIVISION REGULATIONS" of GENERAL ORDINANCES for the Town of Salem, Va.

As a condition precedent to the approval of the final plat and subdivision, and the acceptance of the dedication of the Highway shown hereon, by the Council, doth on his or their own behalf and for and on account of his or their heirs, successors, devisees, and assigns, specifically release the Town of Salem from any and all claim or claims for damages which such owner or owners, his or their heirs, successors, devisees and assigns, may or might have against the Town of Salem by reason of establishing proper grade lines on and along such Highway, as shown on this plat of land subdivided (or such changed streets or alleys as may be agreed upon in the future) and by reason of doing necessary grading cutting or filling for the purpose of placing said Highway and any future streets and alleys upon the proper grade as may, from time to time, be established by said Town, and said Town, shall not be required to construct any retaining wall or walls, along the streets and alleys and property lines thereof.
