

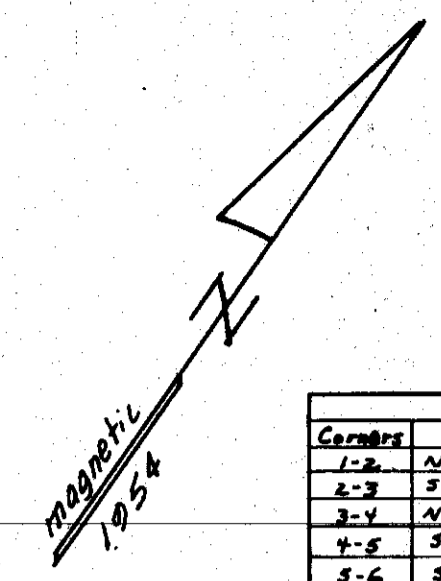
MAP OF

4. No livestock or poultry of any kind shall be kept on any lot shown hereon.

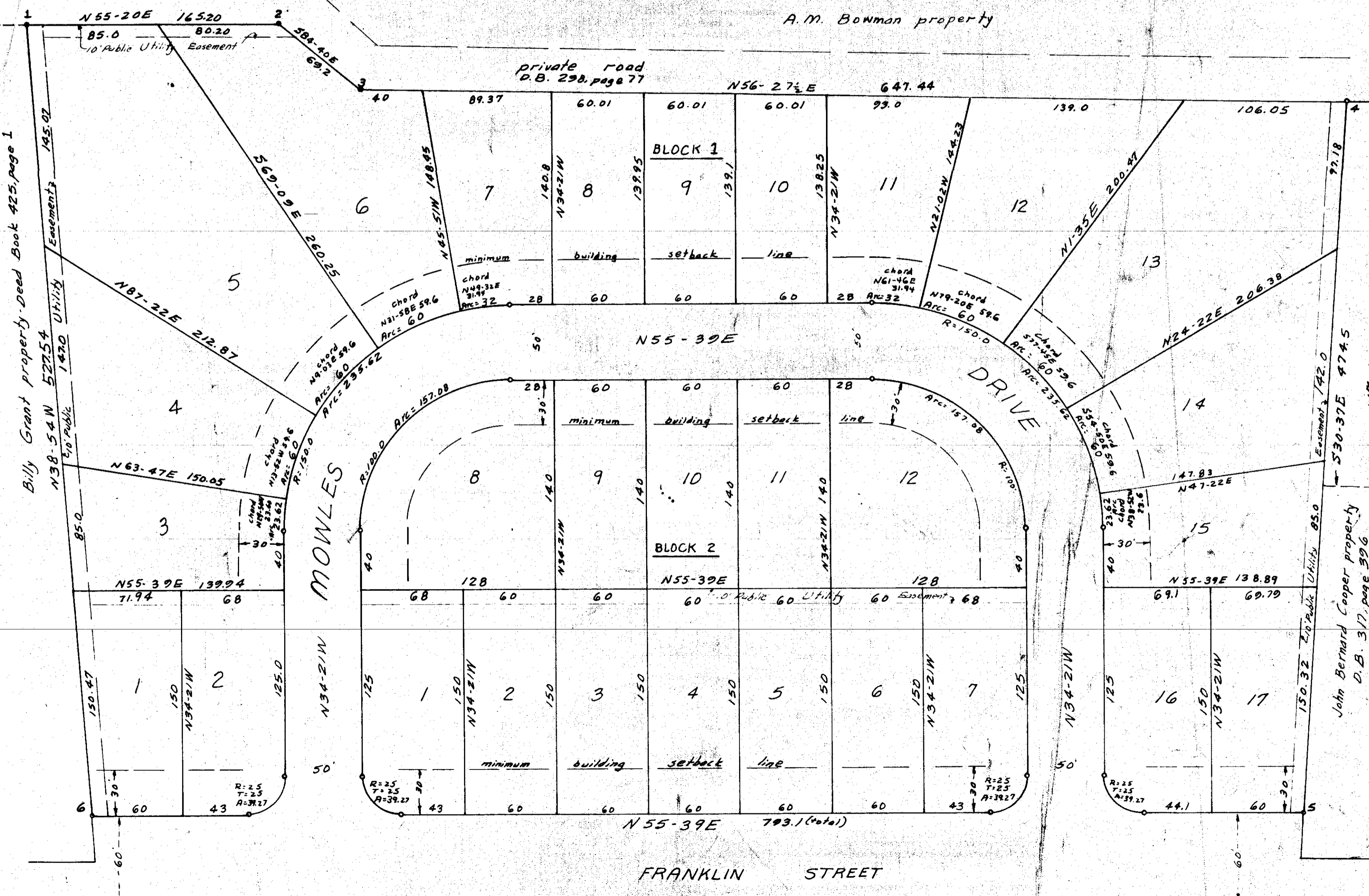
