

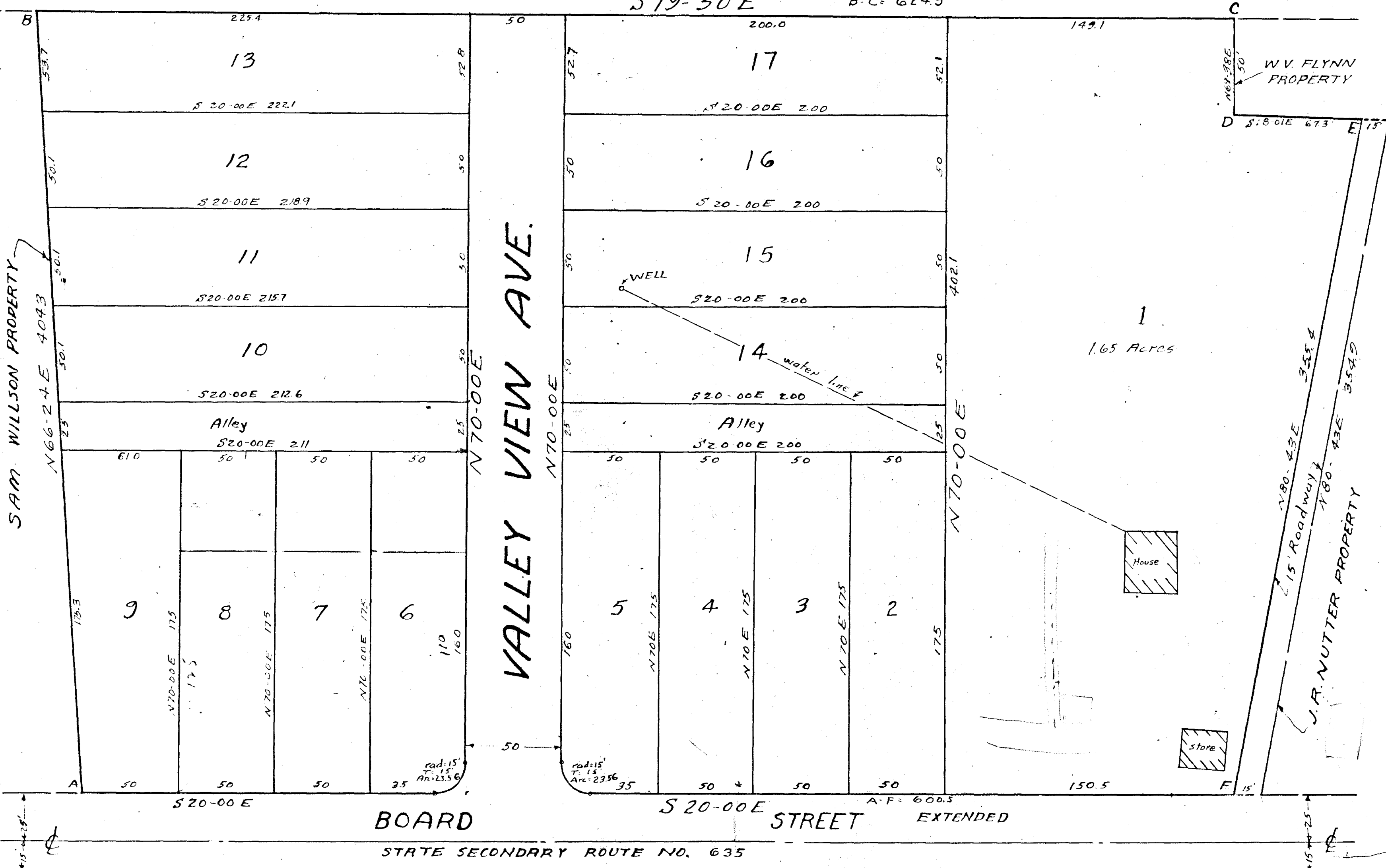


SUBDIVISION OF PROPERTY OWNED BY
