Know all men by these presents, to wit:

That C. A. Crabtree is the owner of the tract of land shown hereon bounded by corners 1 through 8 to 11, which said tract of land is a portion of the property conveyed to said owner by deed from Clarence W. Thomas dated March 15, 1949 and recorded in deed Book #20 page 360 in the Clerks Office for the Circuit Court of Roanoke County, Va.

The said owner as is evidenced by his signing this plat, doth hereby dedicate to the Town of Salem in fee simple all the land shown for widening Bland Street. The said owner certifies that he has subdivided this land into lots as shown hereon, entirely with his own free will and accord, pursuant to and in compliance with Section 15-779 through 15-794.3 of the Virginia Code of 1950 as amended to date, and further pursuant to and in compliance with Title 15, Chapter Two (2) "Land Subdivision Regulations" as amended to date, of the General Ordinances of the Town of Salem, Va. The said owner further certifies that as a condition precedent to the approval of this plat by the Planning Commission of the Town of Salem and its Council, he doth hereby release the Town of Salem from any and all claim or claims for damages which said owner his heirs, devisees, successors and assigns may have or or acquire against the Town of Salem by reason of establishing proper grade lines on and along the streets abutting said subdivision and by reason of doing the necessary grading and filling for the purpose of placing said street upon the proper grade as may from time to time be established by the Town of Salem and said Town shall not be required to construct any retaining wall or walls along said streets.

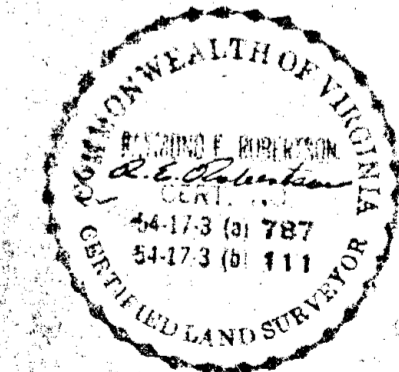
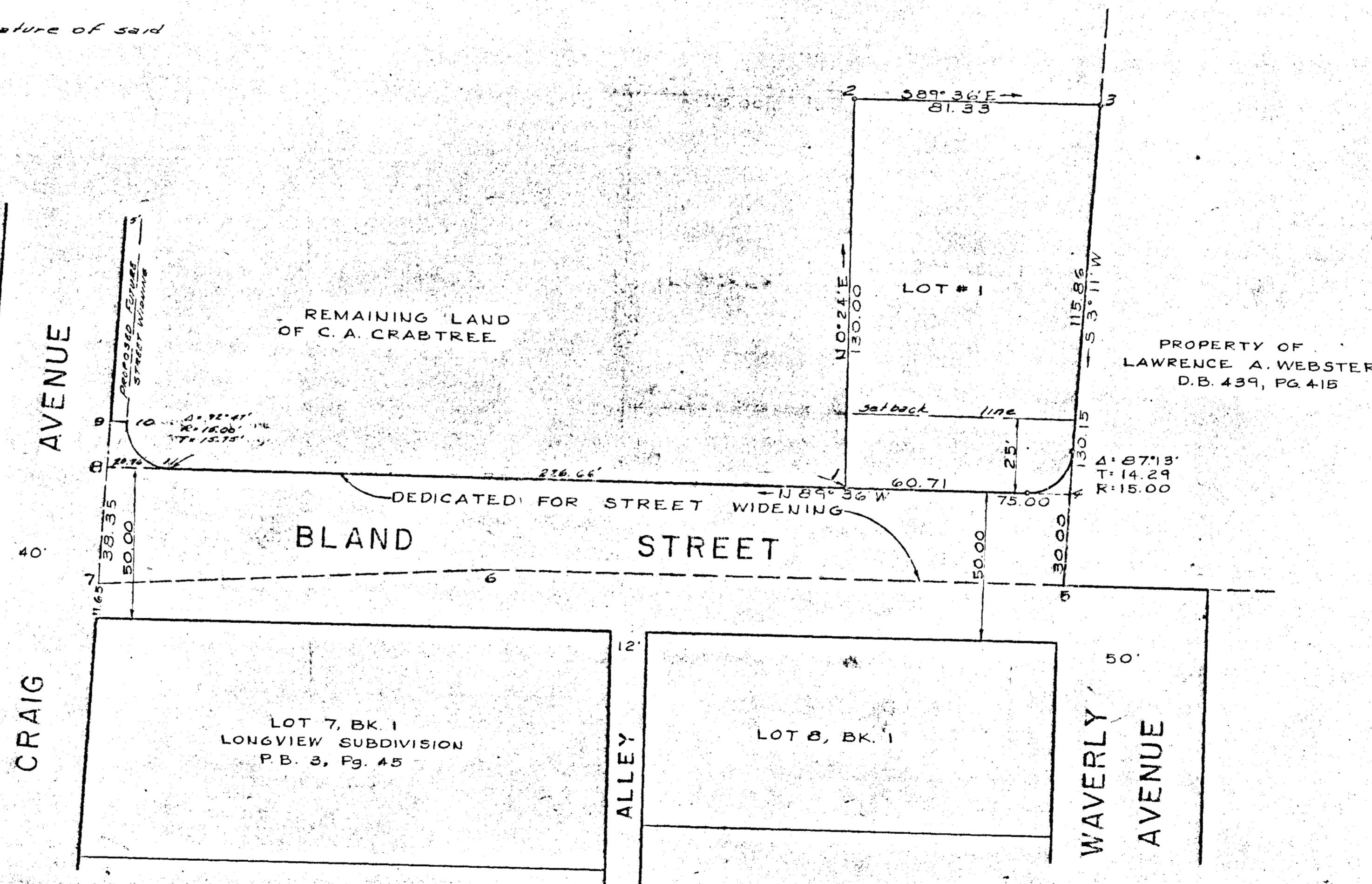
